**Singapore, 9 October 2019** – Far East Organization's The Scotts Tower (TST) has been awarded a FIABCI Singapore Property Awards in the Residential - High-rise category. The award winner is eligible to compete in the international real estate competition, FIABCI World Prix d'Excellence Awards, to be held in Manila in May 2020.

The Scotts Tower (TST) is a high-rise residential development conceptualised by Red Dot awardwinning principal architect Ben van Berkel of UNStudio, Amsterdam. The 31-storey tower comprises 231 one- to three-bedroom SOHOstyled apartments with 3.35m-high ceilings, and floor-to-ceiling windows, featuring a Sky Terrace completed with lifestyle facilities on the 25<sup>th</sup> floor, which offers a 360° view of prime Orchard
